
# Masks, Abuse & Funding

## A Child's Right to Breath

Our Right to Life includes the freedom to breathe fresh air, but your masking policy denies our children their right. When a person exhales through a mask, 2 oz. of toxic, dead air remains trapped inside. Every masked person must first re-inhale that 2 oz. of dead air before drawing in fresh, oxygenated air from beyond the mask. The amount of air that a person can inhale on one breath is called Tidal Volume.



On this chart, the Tidal Volume of different sized people is marked in blue, and the 2 ounces of dead air is marked in red. You can easily see that the smaller the person, the more detrimental the effect of the dead air becomes. Whereas dead air comprises only 10% of every breath for a 180-pound adult, it comprises about ONE QUARTER of each breath for a 10-year-old, ONE HALF of each breath for a 5-year-old, and nearly THREE QUARTERS of each breath for a 2-year-old.\*

Think of all the kindergarteners in this district. Your masking policy is robbing them of HALF of the oxygenated air their growing bodies and developing brains need for nearly 8 hours a day, 5 days a week!!! Even more devastating, for each breath a masked 2-year-old inhales, they only gain 0.9 ounces of fresh, oxygenated air. This data irrefutably proves that masks are dangerous and ABUSIVE to our children!! In light of this data you MUST ask yourself: Am I doing what is right for the children?!

#### **Masks Violate Minnesota Law**

According to MN Statue 609.735, concealing your identity with a mask is a misdemeanor and according to MN Statute 260E.03, the definition of abuse includes: "interference with a child's breathing." Depriving growing, learning children of the very oxygen their bodies and brains need because of a virus they have a 99.997% survival rate from is absolute ABUSE!

## Forcing Masks on Children is Abuse

School Board Members are supposed to be mandatory reporters of child abuse, not perpetrators of it! Based on this data, every parent in this district has the legal right to call the police and social services if you force masks on their children or try to deny them an education because they are asserting their right to breathe.

It doesn't matter what state or federal organization recommends masks – or what they may be paying you to make your policies -- unless they back it up with hard data and proof that masks can block a virus that is 1/1000 the size of a human hair without causing additional damage to the wearer's health, their recommendation means NOTHING! Following the "medical authorities" because they "say so" is NOT science.

#### Where is the Money

And speaking of money, the State of Minnesota is receiving over 1.3 BILLION dollars in federal funds – of which our local district will receive \$4 million dollars -- in exchange for submitting an approved American Rescue Plan for how we will use these ESSER funds. The plan includes a commitment to follow the most up to date CDC guidance -- which currently recommends the UNIVERSAL MASKING of our children. Given this data, has our district committed to following certain covid-19 protocols in exchange for funding? Are you essentially masking our children for money!? We the people demand answers and transparency.

### **Fact Summary**

<u>Fact #1:</u> CHILDREN are NOT at risk!!! As of July 1st, updated data from the MDH & the CDC concludes that in Minnesota, young people under age 29 have a 99.999% survival rate.1 This statistic ALONE says it all, and should be enough to settle any debate. Because students are NOT at risk from covid-19, imposing masks, requiring vaccines, or placing any other restriction on students' learning is completely unnecessary and utterly abusive.

Fact #2: Masks DO NOT work!! Covid-19 virion particles are small enough to go through ANY face mask, and multiple randomized controlled tests and meta-analysis reviews have ALL shown that masks do NOT work to prevent respiratory, influenza like illnesses.2 One of the most conclusive studies is a randomized, controlled trial completed in Denmark with 6,000 participants in May 2020 which concluded that there was "NO statistically significant effect of face masks on covid-19 infection rates."3 Biology Professors from the University of Louisville, KY calculated total Covid-19 case growth rates and mask use for the continental United States with data from the CDC and Institute for Health Metrics and Evaluation. They observed NO "association between mask mandates or used and reduced Covid-19 spread."4 Data collected throughout the year from schools in Florida, New York and Massachusetts shows that mitigation efforts such as masking had almost NO impact on case rates among students. "We do not find ANY correlation with mask mandates."5

Fact #3: Masks are NOT safe! Masks actually increase the risk of illness because they trap exhaled viruses which are then re-inhaled through the nose and into the brain.6 Bacterial pneumonias are on the rise as a result of moisture collection in face masks. In Florida, six children's masks were tested by a lab after being worn for 5-8 hours. The analysis detected 11 dangerous pathogens including, pneumonia, tuberculosis, and meningitis. 7 Dental studies show a rise in gum disease and tooth decay in a condition called "mask mouth."8 Masks reduce the intake of oxygen and lead to carbon dioxide toxicity. On June 30th, a randomized, clinical trial demonstrated that in just 3 minutes of mask use in children, the carbon dioxide levels climbed 6 times higher than the legal limit.8 This leads to dizziness, shortness of breath, and decreased neurological function. Masking our children is quite literally toxifying their bodies and handicapping their minds.

Fact # 4 The Federal Government is paying Minnesota over \$1.3 billion dollars in American Rescue Plan ESSER funds to follow the most up to date guidance from the CDC, which includes the universal masking of OUR children.9 The public has a right to know if our district is receiving any of these funds in exchange for adherence to certain protocols. In the absence of actual facts supporting your policies, have you decided to mask our children for profit!?
